The Prime Minister has announced a road map for how and when the UK will adjust its response to the COVID-19 crisis. This plan seeks to return life to as close to normal as possible, for as many people as possible, as fast and fairly as possible, in a way that is safe and continues to protect our NHS.

Covid-19 Recovery Strategy

The <u>Government's COVID-19 Recovery Strategy</u> details how we plan to rebuild the UK, protect the health and safety of the British public, save lives and livelihoods

Step 1:

- We said that you should work from home if you can, and only go to work if you must. We now need to stress that anyone who can't work from home, for instance those in construction or manufacturing, should be actively encouraged to go to work.
- People can now take more and unlimited amounts of exercise outside. People can sit in the sun in the park, drive to other destinations, and can meet one person from outside of their household if they are outdoors. Garden centres can reopen. Outdoor sports courts, such as golf courses and tennis courts, can reopen. Sports courts, such as golf courses and tennis courts, can reopen.
- You must obey the rules on social distancing and to enforce those rules we will increase the fines for the small minority who break them.

Step 2:

- At the earliest, by June 1 after half term we believe we may be in a position to begin the phased reopening of shops and to get primary pupils back into schools, in stages, beginning with reception, Year 1 and Year 6.
- Our ambition is that secondary pupils facing exams next year will get at least some time with their teachers before the holidays.
- The Government also hopes to begin the phased reopening of some non-essential retail shops that are currently closed.

Step 3:

• At the earliest by July - subject to these conditions and further scientific advice; if and only if the numbers support it we will hope to re-open at least some of the hospitality industry and other public places, if they are safe and enforce social distancing.

- Queen Elizabeth Hospital, King's Lynn

Updates

As you may know the government has extended the date for the Coronavirus Extension Scheme to apply to those who created and started a PAYE payroll scheme on or before 19 March 2020– details <u>here</u> and <u>guidelines on how to apply here</u>.

On top on this, the <u>Chancellor has announced</u> that the Job Retention Scheme will be extended for four months, until the end of October. Until the end of July, there will be no changes to the scheme whatsoever.

From August to October the scheme will continue, for all sectors and all regions of the UK, but with greater flexibility to support the transition back to work. Employers currently using the scheme will be able to bring back furloughed employees part time. The Government will ask employers to start sharing, with the Government, the costs of paying people's salaries.

Workers will, through the combined efforts of Government and employers, continue to receive the same level of support as they do now, at 80% of their salary, up to £2,500. Further detail will follow by the end of May. Read more <u>here</u>.

Bounce Back Loan

You may also be interested to know that the Government has announced a scheme for those in need of smaller loans. Businesses can apply for the new Bounce Back Loans up to a maximum of £50,000, or 25% of turnover, with the government paying the interest for the first 12 months and the Government will support lending by guaranteeing 100% of the loan.
